#### PHILIPPINE DEALING & EXCHANGE CORP.

The Philippine Dealing & Exchange Corp. (PDEx) is a registered trading market for fixed income securities, providing trading and clearing and settlement services, as well as the oversight of an SEC-registered Self-Regulatory Organization (SRO). The infrastructure provides a centralized electronic platform for trading fixed-income securities to deliver price discovery, transparency and investor protection. It likewise operates a trading platform for the foreign exchange trading activities of the members of the Bankers Association of the Philippines.

#### PHILIPPINE DEPOSITORY & TRUST CORP.

The Philippine Depository & Trust Corp. (PDTC) acts as depository, registry, custodian, and/or trustee of its participants of all kinds of securities or financial instruments. The operations of the central depository make possible the paperless securities settlement environment through its electronic book-entry system, incorporating greater efficiency and security in the settlement infrastructure for both the equities and debt markets.

#### PHILIPPINE SECURITIES SETTLEMENT CORP.

The Philippine Securities Settlement Corp. (PSSC) is the payments and settlements arm of the PDS Group. It operates two systematically important payment systems in the Philippines, the Philippine Domestic Dollar Transfer System (PDDTS) and the Payment vs. Payment (PvP) system. Its settlement highways are uniquely customized to cater to the Philippine market. Its payments systems are under the oversight of the central bank as their functioning poses critical systemic impact to the banking community.

**PDS Academy** is a non-stock, non-profit association driven to sponsor and conduct training programs and symposia intended to promote dialogue among stakeholders in the Philippine financial markets.
